

# Conditions for signing independent solar container projects





## Overview

Our team has broken down the most common agreement terms and outlined what landowners can expect. In April 2011, SB 2 (1X) (Simitian) was signed into law, which codified a 33% RPS requirement to be achieved by 2020. A solar contract is a signed agreement between a person and a solar power installation company that clearly outlines every part of the solar panel installation process, including the steps before, during, and after the actual installation, and who is responsible for each. 1 Under an EPC Contract, a Contractor is obliged to deliver a complete facility to the Project Company. When a solar project is owned by an independent power producer rather than a utility serving its own load, the agreement that provides for an assured source of revenue from the energy output and related environmental attributes of the project is central to the project's viability.
