Overview

Trade Representative (USTR) completed a statutory review of tariffs imposed on China for purported unfair “technology transfer” policies that “burden or restrict U. In response to Beijing’s attempts to cement its dominant position across the “new three” technologies of solar photovoltaics (PVs), electric vehicles (EVs), and batteries, the Biden administration is poised to issue tariffs on key Chinese products. Since 2021, the US has imported over \$100 billion in electric storage batteries and. The People’s Republic of China (PRC or China) currently dominates global supply chains and production capacity for clean energy technologies.

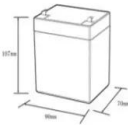


